

**FARMERS COOPERATIVE
2026 HOME RUN REWARDS PROMOTION OFFICIAL RULES**

1. **SPONSOR:** The sponsor of the gift enterprise promotion is Farmers Cooperative, 208 W. Depot Street, Dorchester, Nebraska 68343 (the “Sponsor”).
2. **PRIZES/ APPROXIMATE RETAIL VALUE/ODDS OF WINNING.** Three (3) prize packages will be awarded during the Promotion Period. Each prize package (the “Prize”) will consist of one (1) customized Grizzly® 45 cooler and other locally-sourced goods with an approximate retail value of \$499.99. No substitution, assignment or transfer of any Prize is permitted, except as determined in the sole discretion of Sponsor, who reserves the right to substitute the prize with another prize of equal or greater value. The Prize Winner is solely responsible for any and all applicable fees and federal, state and/or local taxes associated with Prize receipt and use. Odds of winning a Prize depend on the total number of eligible entries received by the Sponsor during the Promotion Period.
3. **PROMOTION PERIOD:** The Promotion starts at 12:00:00 AM Central Standard Time (“CST”) on April 1, 2026 and ends at 11:59:59 PM CST on June 31, 2026 (the “Promotion Period”).
4. **ELIGIBILITY:** The Promotion is open only to residents of the United States who are 19 years of age or older at time of entry that have successfully signed up for, and maintain eligibility under, the Farmers Cooperative Home Run Rewards Program. A participant shall receive one (1) entry in the Promotion, and a participant may only win one (1) Prize during this Promotion. Persons in any of the following categories are not eligible to participate or win a Prize: (a) employees of Sponsor, its prize providers and licensors, and each of the foregoing entities' affiliates and other related entities; (b) any individual or entity associated with the development, judging or administration of the Promotion; and (c) persons who are members of the immediate families (spouses, children, siblings, parents), or who reside in the same household as any person in either of the preceding categories. Illegible or incomplete entries will be disqualified. This Promotion is in no way sponsored or endorsed by Grizzly® Coolers or other manufacturer/distributor of the Prize (or any portion of the Prize).
5. **ENTRY:** Except as otherwise contemplated in these Official Rules, and to the extent entrants may otherwise elect at the time of entry, personal information collected in connection with the Promotion will be used in accordance with the online privacy policy (Privacy & Terms of Service) available at <https://www.farmersco-operative.com/>. Any communication or information transmitted to Sponsor by e-mail or otherwise is and will be treated as non-confidential and non-proprietary. Proof of Entry is not considered proof of delivery to or receipt of such entry. Furthermore, Sponsor shall have no liability for any Entry that is lost, intercepted or not received by Sponsor. Sponsor is the official time keeper for the Promotion. All entry information and materials, including any copy of the Entry submitted to Sponsor, become the property of Sponsor and will not be acknowledged or returned.
6. **PRIZE WINNERS SELECTION:** The Prize winners will be selected by a representative of Sponsor by means of a random drawing on the end of each month (April, May, June) 2026. The winners will have thirty (30) days to claim the Prizes. Additionally, if any winner is deemed ineligible or if any winner rejects the Prize, the Sponsor shall select and notify an alternate winner in accordance with these Official Rules. All of Sponsor’s decisions related to this Promotion will be final and binding in all respects.
7. **GRAND PRIZE WINNERS NOTIFICATION:** To be declared the winner, the potential winner of a Prize will be notified by the Sponsor using the contact information provided at the time of entry. The Sponsor shall have no liability if the winner notification is lost, intercepted or not received by the potential winner for any reason. If, despite reasonable efforts, the potential winner does not respond within five (5) business days of the first notification attempt, or if the prize notification is returned as unclaimed or undeliverable to the potential winner, the potential winner will forfeit the Prize and an alternate potential winner may be randomly selected as determined in the sole discretion of the Sponsor.
8. **GENERAL:** By entering the Promotion, entrants agree to abide and be bound by these Official Rules and the decisions of the Sponsor with respect to all aspects of the Promotion, which are final and binding in all respects relating to this Promotion. Participation in the Promotion constitutes a Prize Winner’s consent to Sponsor’s use of Prize Winner’s submitted information, including Prize Winner’s name, photograph, likeness, voice, biographical information, statements and address (city and state) for

advertising and/or publicity purposes worldwide and in all forms of media now known or hereafter developed, in perpetuity, without further compensation, unless prohibited by law. ENTRANTS AGREE THAT ANY AND ALL CLAIMS, JUDGMENTS, AND AWARDS FOR DAMAGES SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION, AND SHALL BE LIMITED TO ACTUAL OUT-OF-POCKET COSTS INCURRED, BUT IN NO EVENT SHALL ENTRANTS BE PERMITTED TO OBTAIN AWARDS FOR ATTORNEY FEES, PUNITIVE DAMAGES, INCIDENTAL AND CONSEQUENTIAL DAMAGES, AND ANY OTHER DAMAGES OTHER THAN FOR ACTUAL OUT-OF-POCKET EXPENSES; PROVIDED, HOWEVER, THAT SOME JURISDICTIONS MAY NOT ALLOW LIMITATIONS OR EXCLUSIONS FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES OR EXCLUSIONS OF IMPLIED WARRANTIES. THE LIMITATIONS SET FORTH ABOVE SHALL BE INTERPRETED AND SHALL APPLY TO THE FULLEST EXTENT ALLOWED BY APPLICABLE LAWS.

In the event that the Sponsor is prevented from awarding and Prize or continuing with the Promotion as contemplated herein by suspected corruption, fraud or any event beyond its control, the Sponsor shall have the right to modify, suspend, or terminate the Promotion. If the Promotion is terminated or suspended before the end of the Promotion Period, notice thereof will be posted on the Sponsor's website and the Sponsor will (if possible) select winners in a random drawing from all eligible, non-suspect registered entrants as of the date of the event giving rise to the termination.

The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.
